### Chris Found ALWAYS

Chris\* came to ALWAYS seeking family law help. Chris had experienced the foster care system as a minor, lived in a group home, and became a father at the age of 18. He attempted to co-parent with the child's mother, but when she abused the child, Chris knew he needed to keep their child safe. He didn't want his child to grow up experiencing the same violence he had.

Fortunately, Chris's DCS caseworker referred him to ALWAYS. Chris's attorney advocated for the safety of his child in family court. Chris now lives with his daughter and works full-time to support their family of two.

## JULIA'S LONG ROAD TO CITIZENSHIP

Julia was brought to the U.S. from Eastern Europe through an adoption that was later terminated. As a young adult, she fled a labor trafficking situation and found shelter with a Tucson homeless youth provider, which led her to ALWAYS. That was three years ago, but ALWAYS never stopped fighting for her claim to U.S. citizenship.

Julia worked closely with her ALWAYS attorney to piece together her past, including tracking down former adoptive parents. When Julia was recently granted U.S. Citizenship, her ALWAYS attorney stood proudly at her side.
