

CHINDA'S STORY

Chinda* was trafficked in a massage parlor. With the support of law enforcement, she obtained a T visa for trafficking survivors. She was working to get back on her feet when she became pregnant from a man who mentally and physically abused her.

When he hit her with their child in her arms, she left and found ALWAYS to represent her in family court. During trial, her abuser admitted harming

Chinda but remarked that it was not significant. Due to his violent behavior, the judge ordered supervised visits so a third party would monitor the child's safety.

ALWAYS is proud to have put an attorney at Chinda's side to help her stand up to her abuser and protect her daughter. (*Client's name is changed. She is not pictured.)



ALWAYS represents many young mothers. This client shared that when no one else was on her side, her ALWAYS attorneys were there for her.
